**Payment of the Bills**: in the amount of \$10,398.45. Motion by Rice to approve payment of the bills in the amount of \$10,398.45, second by Baker, All ayes, motion carried.

**State of Michigan Treasury Dept:** mistakenly took **Sales Taxes** from the Village Act 51 money since January 2018, we have filed the correct paperwork as the Village should never have had to pay sales tax as it is a government. Working to on the return of the \$24,564.95 that was withheld; we are still waiting for paperwork from the MI. St. Treasury to confirm refund amounts.

**Budget Amendments:** A Budget Committee meeting will be scheduled soon to discuss any amendments and to budget for the Master Plan, CIP and Parks & Recreation 5 year plans.

**Restricted Fund:** A new restricted fund will be set up for half of the Medical Marihuana License money received to be set aside for future matching funds for grant uses.

**Workman's Compensation audit:** the Village goes through the Michigan Municipal League for its Workers Compensation fund; every three years a physical audit is done, we will receive the date soon.

**Parks/Community Development:** Wightman developed a Park Improvement Survey, it was mailed out in all the Utility Billings in July, deadline is August 30, 2018 and it is also available on the Village Website: eauclairemi.com.

Water, Sewer, Solid Waste: More Meter Pits have been installed. A final count is needed.

Streets:

**Planning Commission:** The Planning Commission is still in need of one member.

**Equipment:** The public works garage heater still needs to be looked at to be replaced. This will need to be done before winter. Now is the time to get quotes for it.

**Sanitation:** We have had a big problem with people dumping unwanted furniture at the "Village Farm", We believe people have made duplicate keys. From now on the "Farm Key" won't be allowed out for the entire weekend, there was a discussion about having a deposit on the key, and the Village will most likely get cameras to monitor it. People have also been dumping items behind the Village Hall on the weekends, this costs the Village additional money as a dumpster will have to be rented for all the extra items. No Dumping signs will be posted in back of the building; we are also looking into security cameras for that area.
